



ABSTRACT OF KEYNOTE ADDRESS

Prophet Muhammad (PBUH) in a Pluralistic Context - A Theological Perspective

Abstract

Prophet Muhammad (PBUH) occupies a central position in Islamic theology, serving not only as the bearer of the Qur'anic revelation but also as the final messenger in the prophetic tradition. Within a pluralistic framework, his mission is not restricted to the Muslim community but is articulated in the Qur'an as universal in scope. The verse, "We have not sent you except as a mercy to all the worlds" (Qur' an 21:107), establishes the theological foundation for his role as a comprehensive source of mercy that encompasses humanity, the natural order, and even the unseen realms. Meanwhile the verse "Had God willed, He could have made you one community, but He willed to test you in what He has given you" (Qur'an 5:48) highlights diversity as part of divine wisdom. Theologically, this signals that religious plurality is not a human accident but a divinely sanctioned reality. However, it should be understood here that although Prophet Muhammad (PBUH) recognized the divinely ordained condition of religious plurality and affirmed coexistence as part of God's will, he did not relativize the absolute claims of Islam's revealed truth. His acknowledgment of diversity was thus framed within a theological commitment to the universality and finality of the Qur'anic message.

ABSTRACTS OF SCHOLARLY PRESENTATIONS

Prophetic Sīrah as a Framework for Countering Extremism

Abstract

According to Joseph W. Meri (2016), there is a tendency to equate extremism with a particular religion, race, or group. This is compounded by the common misperception that Islam condones violence and terrorism. Meri contends that violent acts are not inherent to the ontology of any religion—be it Islam, Judaism, or Christianity—or to any sacred scripture, such as the Quran, Torah, or Bible. Furthermore, there is no such evidence to prove that Islamic history is replete with instances of pogroms against non-Muslims. In contrast, the Prophet Muhammad (SAW) provided ethical guidelines through his Sīrah (biography) to promote harmony and reject extremism, or ghuluw. The Sīrah Nabawiyyah serves as a fundamental exemplary model for Muslims, extending beyond a mere historical account to provide a paradigm for justice and peaceful coexistence for all humanity. This is demonstrated through the ethical principles the Prophet (SAW) established, which include mercy and compassion (rahmah), justice and fairness ('adl), balance (tawazun/wasaa), and mutual respect and engagement. This article aims to demonstrate that the life of the Prophet (SAW) provides an authentic Islamic framework for peaceful coexistence and for countering extremism in contemporary society. It will do so by presenting examples from the historical records of the Prophet's life that illustrate his approach to countering extremism.

Prophet Muhammad's (PBUH) Ethics in Pluralistic Societies

Abstract

This paper presents a systematic analysis of the moral and ethical principles exemplified by Prophet Muhammad (PBUH) in his interactions with both Muslims and non-Muslims. It argues that his conduct was not merely situational but constituted a comprehensive ethical framework rooted in the Qur'anic values of justice, compassion, and universal human dignity. The study employs a historical-textual methodology, examining primary sources including the Qur'an and Hadith to delineate the core tenets of his character, such as honesty, trustworthiness, and patience. The paper further investigates the practical application of these principles across diverse social contexts. It analyzes his dealings with non-Muslim tribes and his respectful engagements with religious communities. This study concludes that these principles remain a vital resource for addressing modern challenges of social harmony and peaceful cohabitation.

- Implement Practical Interfaith Initiatives: Using the Prophet's (PBUH) interactions as a model, we recommend establishing sustained, action-oriented interfaith dialogues and community service projects that address common social issues, moving beyond theoretical discussion to practical cooperation.

3. For Policymakers and Civil Society:

- Utilize the Sīrah for Social Policy: We recommend that policymakers and NGOs study the Prophet's (PBUH) model as a social reformer to derive principles for crafting policies that promote social cohesion, economic justice, and the protection of minority rights.
- Leverage the Sīrah for Counter-Extremism: The papers presented on this topic should be compiled into a whitepaper for relevant national and international bodies, showcasing the Sīrah as a powerful, theological antidote to violent extremism and radicalization.

4. For the Muslim Ummah, Particularly in Pluralistic Societies:

- Embrace the Universal Mercy of the Prophet (PBUH): We call upon Muslims worldwide to internalize and project the merciful and compassionate character of the Prophet (PBUH) in all their interactions, thereby embodying the true spirit of his message.
- Act as Ambassadors for Coexistence: Inspired by the symposium, Muslims, especially those living as minorities, should actively engage as bridge-builders and contributors to their societies, demonstrating through action the relevance of the Prophetic example in fostering harmony and mutual respect.
